#### **General Terms & Conditions:**

- 1. Bidder must be authorized dealer/supplier of make mentioned in the Annexure A, no other make will be accepted and the bid of other make will be rejected automatically.
- 2. The Authorized Dealer/Supplier Certificate must be attached with the bid, otherwise the bid will be treated as rejected.
- 3. The quotations received after 26th April 2024 up to 3:00 PM or unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay, this Institute will not be responsible. The offer Submitted by/through Fax/Email shall not be considered and no correspondence will be entertained in
- 4. Quotations must be in the enclosed prescribed format duly signed by the Proprietor/Partner/Director or their 2 Authorized Representative, in case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in "Quotation Box" located in Administration Block of AIIMS, Jodhpur. Quotation must be in a sealed envelope super scribed with inquiry number.
- 5. Rates must be quoted in "Indian Rupees" and bidder should give rates, showing taxes, levies, if any, in the prescribed format. Quotation not conforming to these requirements shall be rejected and no correspondence will be entertained whatsoever.
- 6. Rates must be quoted FOR basis (including Freight charges, Insurance, installation, commissioning, etc.)
- 7. No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- 8. The rates quoted must be valid for 90 days minimum from the date of opening of the quotation.
- 9. L1 will be decided on composite basis. Becoming L1 will not be the criteria for awarding of work unless the rates are reasonable & justified.
- 10. RTGS/NEFT details need to be furnished by the bidder with the quotation on the Annexure A.
- 11. Quotations qualified by such vague and indefinite expressions such as "subject to prior confirmation", "subject to immediate acceptance" etc. will be treated as vague offers and rejected accordingly. Any conditional quotation shall be rejected summarily.
- 12. The time allowed to complete the work of SITC as per details mentioned in Annexure A is 10 days from the date of issue of award letter.
- 13. Contractor shall be fully responsible for any damages caused to govt. property or allottee's property by his or his labour in carrying out the work and shall be rectified by the contractor at his own cost.
- 14. Disputes: In the event of any dispute or disagreement arising between the contractors and any other department of AIIMS Jodhpur with regards to the interpretation of "Terms & Conditions" of this inquiry, the same shall be referred to the Executive Director, AIIMS Jodhpur whose decision will be final and binding. Any disputes are subject to exclusive jurisdiction of competent court and forum in Jodhpur, Rajasthan, India only.
- 15. The Arbitration shall be held in accordance with the provision of the Arbitration and conciliations Act, 1996 and the venue of arbitration shall be at Jodhpur. The decision of the Arbitrator shall be final and binding on both the parties.
- 16. AIIMS, Jodhpur reserves the right to increase or decrease quantity and/or amount of work.

- 17. AlIMS, Jodhpur reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of the AIIMS, Jodhpur will be final in this regard.
- 18. The contract shall be governed by laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such commercial dealings/processing.
- 19. Force Majeure: Any delay due to Force Majeure will not be attributable to the service provider.

#### Special Terms & Conditions:

- 1. Bidder must quote rate in Price Bid Form provided in Annexure A.
- 2. The bidder has to supply install test and commission the Air Conditioners at one go.
- 3. It is responsibility of the contractor to Supply, Installation, Testing and Commissioning (SITC) of Air Conditioners at required location, complete with transportation, labour including connection, gas charging, testing, earthing etc. as required and nothing shall be paid extra in this account.
- 4. It is the responsibility of the contractor to watch and ward of their material tools cable, switches etc. during installation at required location, AIIMS Jodhpur shall not be responsible for damage /missing of any item and nothing shall be paid extra in this account.
- 5. The contractor shall be fully responsible for the safety of all labour/employees employed on the work.
- 6. The contractor shall have to arrange all type of tools and special T&P etc. at his own cost as required to carry out work for which nothing extra shall be paid to the contractor by the department.
- 7. There shall be no liability on the AIIMS Jodhpur to pay any compensations arising out of any labour dispute or accident etc at site.
- 8. Workers engaged by the contractor for execution of work shall be liability of the contractor.
- 9. The agency shall be responsible for repair/replacement of defected parts of Air Conditioners during one year of warranty period from installation and nothing shall be paid extra on this account.
