General Conditions of Contract

- 1. Rate: Rates to be quoted as per Financial Bid (BoQ) considering costs of all required works and all their benefits and deductions. The rates shall be quoted only in the schedule of quantities attached with the tender and nowhere else i.e. letter heads etc.
- 2. Validity: The quoted rates must be valid for a period for 180 days from the date of closing of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quoted the validity shorter than the required period, the same will be treated as unresponsive and it may be rejected. In case the tenderer withdraws, modifies or change his offer during the validity period, bid is liable to be rejected without assigning any reason thereof. The bidder should also be ready to extend the validity, if required, without changing any terms, conditions etc. of their original tender. In case the last date of receipt of tender / of opening the tender is declared as Holidays, the respective dates shall be treated as postponed to the next working day accordingly.

3. Technical Evaluation:

- a) Detailed technical evaluation shall be carried out by Institute pursuant to conditions in the tender document to determine the substantial responsiveness of each tender. - **6. Award of Contract:** The Institute shall consider placement of orders for jobs on those bidders whose offers have been found technical and financially acceptable. The Institute reserves the right to counter offer price(s) against price(s) quoted by any bidder.
- 7. Signing of Contract: The successful bidder shall be required to execute the Contract Agreement accepting all terms and conditions stipulated herein on a non-judicial stamp paper of Rs. 500/- (Rs. Five Hundred only) within **fifteen days** of the issue of the Letter of notification of award along with performance security, in the event of failure to sign the Contract within the period stipulated above, the BID shall be considered as cancelled.

8. Performance guarantee:

- a. As a contract security for faithful performance of the contract in accordance with all the terms and conditions specified in the tender the obligations under warranty period, the successful tenderer / contractor shall furnish a Performance guarantee @ 3% of order value in the form of Fixed Deposit Receipt or Bank Guarantee from any Nationalized Bank duly pledged in the name of the "All India Institute of Medical Sciences, Jodhpur" after receipt of supply order.

19. Applicable Law:

- 21. The work is of comprehensive type and service provider must undertake all the works related to smooth and proper functioning of lifts as per CPWD / CEA norms.
- 22. Any information / document required for verification shall be provided by the bidder.

SPECIAL CONDITIONS OF CONTRACT

- 1. Material / consumable for work shall be procured only from the original equipment manufacturers. The contractor shall submit all documentary details in fulfillment of this conditions regarding procurement of materials including relevant test certificates.
- 2. The contractor shall be responsible and liable for proper and complete maintenance of the Electronics, Electrical and Mechanical component of Lifts.
- 3. Any type of damage done to the equipment/installation during operation of the work shall be made good by the contractor and nothing extra shall be paid for the same, decision of Engineer-in-charge in this matter shall be final and binding.
- 4. The contractor shall handover the entire installation in good working condition after completion of work except normal wear & tear.
- 5. This is purely a service contract. All the staff engaged by the contractor shall be purely his liability and institute no way shall be responsible for any compensation for any of their acts/accidents or providing employment, regularization of services etc.
- 6. The contractor shall provide all necessary normal tools, safety devices etc., and first aid box to his workman to carry out the day-to-day work as per schedule.
- 7. Contractor must maintain the elevators as per the parameters confirm with the latest CEA norms and other statutory laws enacted by Central Govt. as well as State Govt., and quote the rates accordingly.
- 8. Wherever any reference is made of any Indian Standard, it shall be taken as reference to the latest edition with all amendments / revision issued thereto up to the date of receipt of tenders.
- 9. Operations of lifts through lift operators are done by other agency. The lift service provider will coordinate and cooperate the operation staff also.
- 10. No residential accommodation shall be provided to any of the staff engaged by the contractor.
- 11. Lift will be serviced monthly by trained supervisory staff and will reasonably maintain the lift in safe and proper working conditions and have to provide checklist sheet along with service or break down report duly authorized / checked by E-I-C or his authorized representative. The service provider has to provide monthly servicing, safety sticker of OEM of lifts in 02 copies of each. (one to paste in lift and one for office record), safety certificate and smooth running of elevators along with quarterly bill.
- 12. Carry out the service work between 9:00AM to 6:00PM on a day convenient to the AIIMS other than Sundays & Holidays and during regular working hours. The Manufacture/ Authorized agent should have carried out the monthly, preventive maintenance in presence of JE(E)/AE(E) and should submit the records of the same.
- 13. The Manufacture/ Authorized agent will undertake to supply free of charge material required for servicing work and also spare parts, which are worn out as a result of tear & wear for all electrical, electronic, mechanical component like controller, motor, E.M brake, motor re-winding, floor selector, door locks and also for other mechanical part like gear, guide shoes, safety gear, rope etc. Genuine "KONE Make" / recommended by KONE lifts spare parts only will be used.
- 14. The part of the lift will be checked, cleaned and lubricated to keep them mechanically and electrically in perfect working condition.

- 15. The firm shall examine quarterly all safety devices, governors to ensure proper working condition and have to submit report of same to engineering department of AIIMS, Jodhpur.
- 16. Fan, light fittings, mirror and batteries for UPS, Car enclosure, Car flooring, hoist way enclosure, hoist way and car door, gate handles, door beading, door glass, door frames, sills push box covers in landings and car electric incoming mains, main switch, EPABX telephone intercom, shaft lights are not included in the scope of work.
- 17. Repair/overhaul the lifts parts when in joint judgement of AIIMS engineer-in-charge and the company. The conditions warrant and the old parts will be removed and this will become company's property. If in case any part could be replaced and in addition to the contract charge any extra charge is claimed, then the older part shall be AIIMS property
- 18. Upon notification by AIIMS of a breakdown or failure in the elevator, the company shall send a technician within 6 hours to carry out necessary repairs in order to restore the elevator to satisfactory working condition. A normal material shall be replaced within 3 days and major material shall be replaced within 7 days. If any delay in above response, then a penalty of ₹. 1,000/- per day of contract amount shall be impose on the company. However, department shall consider following time frame for redressal of complaint/rectification /repairs etc.-

- 19. Service record duly authorized by E-I-C or his authorized representative shall be provided by the service provider as and when the service of individual lift has been done. Other records like checklist of services done will have to be produced according to the requirement or when asked to do so by the Engineer-in-charge or his authorized representative.
- 20. The Service provider shall ensure to carried out the monthly service in <u>first 7 days of every month</u> if, failure to carry out monthly service within the stipulated time period, penalty of ₹.500 from the first day of month to day till preventive maintenance of that month service will be imposed.
- 21. The personnel and laborers engaged by the contractor under this contract shall wear neat and clean uniforms along with name badges. An identity card issued to each personnel by the service provider to have proper identifications.
- 22. Staff employed by the contractor should be well behaved, Polite & courteous. Any complaint against staff on behavior should be taken very seriously.
- 23. Contractor shall be fully responsible for any damages caused to govt. property by his or his labour in carrying out the work and shall be rectified by the contractor at his own cost.
- 24. The Engineer-in-Charge or his authorized representative shall be at liberty to visit and check the lifts, car tops, control panel and all related installations.

- 25. **Breach of Terms and Conditions**: Noncompliance of any terms and conditions enumerated in the contract shall be treated as breach of contract. In Case of breach of any terms and conditions, the Client have the right to reject the bid at any stage without assigning any reason thereof and nothing will be payable by AIIMS, Jodhpur in that event the PG/SD shall also stands forfeited.
- 26. **Termination of Contract:** AIIMS, Jodhpur would have the right to terminate the contract by giving one month's notice before the expiry of the term, in case the work performance is not up to the standard, or in case there is any violation of AIIMS, Jodhpur rules & regulations, or if there is any lapse in compliance of any labour legislation, or if there is any incident of indiscipline on the part of the Tenderer or his staff and the agreement may be terminated by either party by giving one month's notice to the institution.
- 27. **Arbitration:** The Arbitration shall be held in accordance with the provision of the Arbitration and conciliations Act, 1996 and the venue of arbitration shall be at Jodhpur. The decision of the Arbitrator shall be final and binding on the both parties.
- 28. **Dispute Settlement**: It is mutually agreed that all differences and disputes arising out of or in connection with this agreement shall be settled by mutual discussions and negotiations if such disputes and differences cannot be settled and resolved by discussions and negotiations then the same shall be referred to the sole Arbitrator appointed by the Client whose decision shall be final and binding on both the parties. The contract shall be governed by laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such commercial dealings/ processing.
- 29. In the event of any variation between CPWD / CEA / IS specifications the former shall take precedent over the later. In the event of variation between the nomenclature of item as per schedule of quantities and specifications, the former shall prevail.
