The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quoted the validity shorter than the required period, the same will be treated as unresponsive and it may be rejected. In case the tenderer withdraws, modifies or changes his offer during the validity period, bid is liable to be rejected without assigning any reason thereof. 3. Technical Evaluation:

- b. The determination of bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence. - 4. **Financial Evaluation:** After due evaluation of the bid(s) AIIMS, Jodhpur will award the contract to the lowest evaluated responsive tenderer on a composite basis.
- 5. **Right of acceptance**: The Client have right to accept or reject any or all tenders or cancel or withdraw the tender notice without assigning any reasons thereof. Also, does not bind itself to accept the lowest quotation or any tender and no claim in this regard shall be entertained. Conditional bid/s will be treated as unresponsive and will be rejected.
- 6. **Award of Contract**: The Institute shall consider placement of orders for jobs on those bidders whose offers have been found technical and financially acceptable.
- 7. **Signing of Contract**: The successful bidder shall be required to execute the Contract Agreement accepting all terms and conditions stipulated herein on a non-judicial stamp paper of appropriate value within fifteen days of the issue of the Letter of notification of award along with performance security. In the event of failure on the part of the successful bidder to sign the Contract within the period stipulated above, the EMD shall be forfeited and the acceptance of BID shall be considered as cancelled.

8. Performance bank guarantee:

a. As a contract security for faithful performance of the contract in accordance with all the terms and conditions specified in the tender, the successful bidder shall furnish a Performance bank guarantee @ 5% of order value in the form of Fixed Deposit Receipt or

Bank Guarantee from any Nationalized Bank duly pledged in the name of the "All India Institute of Medical Sciences, Jodhpur" after receipt of work order.

- b. The client has the right to encash the PBG in full or part for non-compliance of any or all the terms and conditions of the tender / contract and to recover any Liquid Damages and penalties under the contract as well as against defects in any work as enumerated in the tender / contract. 9. Security deposit:

- d. The rejected goods shall be replaced by the bidder free of cost within 10 days of intimation by the Engineer In-charge. Only goods found in working condition without any defects shall be accepted.

- d. Force Majeure: Any delay due to Force Majeure will not be attributable to the service provider.
- 21. **Guarantee / Warranty Period**: Warranty period of the supplied products shall be as per additional specification parameters mentioned in the bid document from the date of final acceptance of goods after testing. The contractor must provide the OEM warranty / guarantee certificates for the supplied material at the time of delivery. The seller should guarantee the rectification of goods in case of any breakdown during the guarantee period.
- 22. The quantities are approximate and are liable to change up to any extent on either side.
