- 3. #### 4. Criteria of Eligibility:

- a) The consultant should have experience in design & preparation of detail project report for hospital / cafeteria / canteen kitchen equipment etc.
- b) Should have completed consultancy for Three similar works each of value not less than 40% or Two similar completed works each of value not less than 60% or One similar completed work of value not less than 80% of the estimated project cost put to tender.
- c) The consultant shall submit documentary evidence in support of having experience of providing consultancy and preparing Design & Detail project report in kitchen equipment works.
- d) The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum calculated from the date of completion to the last date of previous month in which bids are received.

#### 5. EMD Payment:

The bidder shall be required to submit the Earnest Money Deposit (EMD) for an amount of ₹ 5,000.00 (Rupees Five thousand only) by way of demand drafts or Bank Guarantee only. ## General Terms & Conditions:

1. Validity: The quoted rates must be valid for a period for 45 days from the date of closing of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quoted the validity shorter than the required period, the same will be treated as unresponsive and it may be rejected.

2. "PRE -BID Meeting" with the intending bidders shall be held on 26th Sept, 2018

from 03:00 P.M. onwards at AIIMS, Jodhpur.

No query after pre-bid meeting shall be entertained regarding the tender.

7. The tenderer(s) is/are required to quote strictly as per the terms and conditions, specifications, standards given in the tender documents and not to stipulate any deviations.

8. AIIMS Jodhpur reserves the right to reject any or all tenders or cancel/withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no tenderer / intending tenderer shall have any claim arising out of such action.

9. Performance Security Deposit:

The successful tenderer will be required to furnish a Performance /Security Deposit of 5% of contract value after receiving work order in the form of Fixed Deposit Receipt or Bank Guarantee from any Nationalized Bank duly pledged in the name of the "All India Institute of Medical Sciences, Jodhpur" which shall be kept valid for a period of 60 days beyond completion of all the contractual obligations.

The security deposit can be forfeited by order of this Institute in the event of any breach or negligence or non-observance of any condition of contract or for unsatisfactory performance or non-observance of any condition of the contract. Performance Security will be discharged after completion of contractor's performance obligations (including Warranty / Guarantee period) under the contract.

#### 10. Commencement of work:

On acceptance of tender, the name of the accredited representative(s) of the Architect / Consultant who would be responsible for taking instructions from Engineer-in-Charge or its authorized representative shall be intimated within 04 days of issue date of letter of award by AIIMS, Jodhpur.

11. The award, of consultancy work, Design & DPR and completion of work shall be governed by tender documents consisting of (but not limited to) Letter of

Award/Letter of work order, Price bid, Special Conditions of Contract, General Conditions of Contract etc. The Tenderers shall be deemed to have gone through the various conditions while making/preparing their technical & financial proposals & submitting the Bid(s) including site conditions, topography of the land, drainage and accessibility etc. or any other condition which in the opinion of tenderer will affect his price/rates before quoting their rates.

12. Consultancy Services for kitchen equipment work needs to be completed by

Contractor within 14 days from issue of letter of work order.

#### 13. Payment terms:

Payments shall be released in following stages:

Stage 1: On approval of Preliminary drawings by Engineer-in-Charge, AIIMS, Jodhpur- 20 %

Stage 2: On finalization of layout plans- 10 %

Stage 3: On finalization of designs and drawings of all services- 20%

Stage 4: On finalization of BOQ & Tender document for procurement and installation of Kitchen equipments- 20%

Stage 5: On completion of Inspection, Installation, Testing and Commissioning of Kitchen equipments- 20%

Stage 6: On satisfactory Completion and Operation of the kitchen and related areas-10%

#### 14. Milestone to be adhered to:

- A. Preliminary drawings to be submitted within 5 days of issue of award of work.
- B. Layout plan to be submitted within 5 days of approval of Preliminary drawing by Engineer-in-Charge.
- C. Service design and drawings to be submitted within 5 days of approval of layout plans.
- D. Finalization of BOQ and Tender document within 5 days of approval of service design and drawings.
  - In case of non adherence of the above timeline, 5% shall be withheld from running payments which shall only be released on completion of the next milestone.
- 15. The quoted fee shall be inclusive of minimum four visits to AIIMS, Jodhpur Site. In case more visits are required than Consultant shall be paid by AIIMS Jodhpur Office, Basni Industrial Area, Phase-2, Jodhpur (Rajasthan)-342005.
- 16. The acceptance of any or all tender(s) will rest with the AIIMS, Jodhpur who does not bind itself to accept the lowest tender and reserves to itself the right to reject any or all of the tenders received without assigning any reason thereof.
- 17. Bidders are required to visit the site and get acquainted with the site conditions, scope of work, work place i.e. IPD hospital kitchen, cafeteria and Medical college canteen before quoting / submitting their bids. Nothing extra shall be payable on this account.
- 18. After due evaluation of the bid(s) AIIMS, Jodhpur will award the contract to the lowest evaluated responsive tenderer. Conditional bid will be treated as unresponsive and will be rejected.
- 19. Legal Jurisdiction: Any disputes are subject to exclusive jurisdiction of competent court and forum in Jodhpur, Rajasthan, India only.
- 20. Applicable Law: The contract shall be governed by laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such commercial dealings/ processing.

- 21. Arbitration: The Arbitration shall be held in accordance with the provision of the Arbitration and conciliations Act, 1996 and the venue of arbitration shall be at Jodhpur. The decision of the Arbitrator shall be final and binding on both the parties
- 22. **Subletting of Work**: The firm shall not assign or sublet the work/job or any part of it to any other person or party without having first obtained permission in writing of AIIMS, Jodhpur, which will be at liberty to refuse if thinks fit. The tender is not transferable. Only one tender shall be submitted by one tenderer.
- 23. **Breach of Terms and Conditions**: In case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to cancel the work order/job without assigning any reason thereof and nothing will be payable by AIIMS, Jodhpur in that event the security deposit shall also stands forfeited.
- 24. **Insolvency etc**: In the event of the firm being adjudged insolvent or having a receiver appointed for it by a court or any other order under the Insolvency Act made against them or in the case of a company the passing any resolution or making of any order for winding up, whether voluntary or otherwise, or in the event of the firm failing to comply with any of the conditions herein specified AIIMS, Jodhpur shall have the power to terminate the contract without any prior notice.

## Brief Scope of work:

The consultancy services should broadly cover the following:

- To understand the requirements.
- To visit the site for preparation of tender documents.
- To prepare the design based report for hospital / cafeteria / canteen kitchen equipment in accordance
  with the best hygiene practices and regulations such as HACCP and FSSAI so as to ensure that kitchen
  have smooth work flow with minimum crisscrossing.
- To conduct economic/technical evaluation of alternate brands/equipment for preparation of detailed estimates/BOQ/specifications/CAD drawings for tender purpose.
- Rate analysis for market rates is to be provided along with Bill of quantities (BOQ).
- Any other information as per the client if required.
- Before final preparation of his design layout, the consultant should give necessary design concept presentation to AIIMS, Jodhpur. Any changes as proposed by AIIMS, Jodhpur are to be incorporated in the final drawing before submission to AIIMS, Jodhpur.
