- 1. The above vacancies are provisional and subject to variation. The Director reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements.
- 2. Reservation will be as per Government of India Policy.

2. <u>UPPER AGE LIMIT AS ON (29th August, 2019)</u>:

- a) For eligibility to apply for these posts upper age limit as on 29th August, 2019 will be 40 years. This is relaxable for SC/ST candidate for a maximum period of five years. In the case of OBC candidates it is relaxable upto a maximum period of three years. In the case of Persons with Benchmark Disability (PwBD) candidates, this is relaxable upto maximum period of Ten years for General Category, Thirteen years for OBC category and Fifteen years for SC/ST category candidates.
- b) The upper age limit in case of Ex-servicemen and Commissioned officers including ECOs / SSCOs / Government servants shall be relaxed by Five years in addition to the relaxation to SC/ST/OBC/PwBD, subject to the condition that on the closing date for receipt of applications the continuous service rendered in the Armed Forces by an Ex-serviceman is not less than six months after attestation. This relaxation is also available to ECOs/SSCOs who have completed their initial period of assignment of five years of military Service and whose assignment has been extended beyond five as on closing date and in whose case the Ministry of Defence issues certificates that they will be released within 3 months on Selection from the date of receipt of offer of appointment. Candidates claiming age relaxation under this para would be required to produce certificate at the time of Interview at AIIMS Gorakhpur.

The candidates who are in service in any Government Institutions are required to submit <u>No Objection Certificate</u> from the employer at the time of Interview.
